

**101 ESPN – “Weekend Getaway” Sweepstakes
Official Rules**

**NO PURCHASE OR PAYMENT NECESSARY. A PURCHASE WILL NOT IMPROVE YOUR CHANCES OF WINNING.
VOID WHERE PROHIBITED BY LAW.**

BY ENTERING THE SWEEPSTAKES, EACH ENTRANT AGREES TO THESE OFFICIAL RULES.

- 1. Eligibility:** The 101 ESPN Weekend Getaway Sweepstakes (the "Sweepstakes") is open only to legal residents of Missouri and Illinois who are 21 years or older at the time of participation. Void outside of MO and IL, and where prohibited by law. No purchase necessary to enter the Sweepstakes. Employees of Hubbard Radio St. Louis, LLC and its station 101ESPN, 11647 Olive Boulevard, St. Louis, MO 63141 (the "Sponsor"), Walter Knoll Florist ("Promotional Participant"), Hubbard Radio, LLC, or any of their respective affiliates, subsidiaries, advertising agencies, or any other company or individual involved with the design, production execution or distribution of the Sweepstakes (collectively with Sponsor, the "Released Parties") and their immediate family (spouse, parents and step-parents, siblings and step-siblings, and children and step-children) and household members of each such employee are not eligible to enter or win. The Sweepstakes is subject to all applicable federal, state and local laws and regulations. Participation constitutes entrant's full and unconditional agreement to these Official Rules and Sponsor's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein. Anyone participating in this sweepstakes or claiming a prize in this sweepstakes in violation of these rules will be disqualified from winning a prize in this sweepstakes and from participating in Sponsor sweepstakes or contests for a period of one (1) year.
- 2. Sweepstakes Period:** The Sweepstakes begins on August 14, 2021, at 12:00:00 AM Central Time ("CT") and ends on September 12, 2021 at 11:59:59 PM CT (the "Sweepstakes Period").
- 3. How to Enter:** To enter, Listeners must register on the 101 ESPN Stream Player (the "App") at <http://www.101espn.com> ("Website"). Once registered, visit a participating Walter Knoll Florist location to find signage featuring the Sweepstakes where you can find and scan the QR Code to enter the Sweepstakes. Once you visit the Walter Knoll Florist location, open the App, visit the Prize Details page, then scan the QR Code through the App to receive one (1) entry into the random drawing. Limit one QR Code entry per person per day.
- 4. Random Drawing:** Then, on or about September 13, 2021, Sponsor will randomly select one (1) Grand Prize winner, and four (4) First Prize winners, from among all eligible entries received. Odds of becoming a winner depend on the number of eligible entries are received during the Sweepstakes Period. The winners will be notified by telephone or through a notification through the App on or about the day of the random drawing. If Sponsor is unable to reach a potential winner after **three (3) attempts**, that potential winner will forfeit his/her right to their Prize, and an alternate potential winner will be selected, time permitting.

ARV: \$898.56. Transportation (except gas card) and parking not included. Tickets are subject to the terms, conditions and restrictions printed on the tickets. Valid credit card due upon hotel check-in. Grand Prize winner and guest must check into the hotel on September 24, 2021 and check out on September 26, 2021 or prize will be forfeited and awarded to an alternate, time permitting.

Sponsor is not responsible for any delays, cancellations or postponements. Gift card is subject to the terms, conditions and restrictions as printed on the card. In the event alcohol is consumed by Grand Prize winner and/or his or her guest, the Grand Prize winner and guest are solely responsible for any claims or issues that may arise from such alcohol consumption. Winner's guest must be at least 21 years of age or older, and sign a Liability and Publicity Release as a condition of being named the official guest prior to issuance of tickets. The winners must prove they are a qualified winner by presenting acceptable identification (e.g., state driver's license; state issued identification card; valid passport with address verification; or birth certificate with social security card and photo identification and address verification). or any other factor beyond Sponsor's reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the participation process or the operation of the Sweepstakes or to be acting in violation of these Official Rules or any other promotion or in an unsportsmanlike or disruptive manner. Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. All issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, or the rights and obligations of the entrant and Sponsor in connection with this Sweepstakes shall be governed by, and construed in accordance with, the laws of the State of Missouri, USA without giving effect to any choice of law or conflict of law rules (whether of State of Missouri, USA or any other jurisdiction), which would cause the application of the laws of any jurisdiction other than the State of Missouri.
